A. Advocacy:

A discussion was held on the Bottle Bill concept for Oklahoma. Jim Bologna and Michael Patton shared information about the benefits of such legislation. Bologna reviewed what had happened since Saint Gobain's initial meeting with Senator Bingman and Representative McCullough. As Jim sees things progressing, he will update the OKRA Executive Board.

Β. Education – Sara Ivey

Sara Ivey reported that there had been 3 entries to OKRA's first America Recycle's Day PSA contest. The theme selected this year was **Beyond the Bin**. The contest, for students in grades 9-12 ran from September 23rd until October 23rd. Prizes will be awarded to 1st, 2nd and 3rd place winners. The prizes are as follows:

o 1st place - \$500.00 to the individual winner, \$50.00 to the Environmental Science Club at the winner's school, 20 free recycling bins for the winner's school and airing of the winning PSA on television stations throughout the state of Oklahoma (depending on the quality of the winning entry)

- o 2nd place \$300.00 to the individual winner, and \$50.00 to the Environmental Science Club at the winner's school, 20 free recycling bins for the school
- o 3rd place \$150.00 to the individual winner, and \$50.00 to the Environmental Science Club at the winner's school, 20 free recycling bins for the school

The funding was equally provided by OKRA and OG&E. Cox Communication served in the capacity of technical advisor.

There will be a meeting at 10:30 a.m. Thursday, November 5th at DEQ to judge the entries.

C. Market Development-

A discussion was held on the new plastic recycling company in Watts, OK. It was agreed upon that it would be good for a representative of OKRA to attend the opening. Someone needs to ask Al Drinkwater to invite OKRA to the ceremony. OKRA should go to and show support. (I can't remember who volunteered to contact AL and don't have it in my notes.)

D. Materials Exchange – Kole Kennedy

Kennedy was unable to attend the meeting and did not send a report. It was reported that Dianne Wilkins of the DEQ committed to send someone to give an overview on how to use the website at the upcoming seminar. Materials exchange, strictly for commercial purposes. A discussion was held on the materials exchange program. It was agreed upon that more marketing needs to be done with OK Chamber of Commerce, etc. In the OKRA NEWSLETTER, make a point to give reference to materials exchange for the next year. The board would like Kennedy to submit an article or summary information in every issue next year. Jim Bologna suggested getting it out to industries that don't even know that it exists. He suggested that OKRA send an overview to facility supervisors or managers.
