STANDING COMMITTEES

Communications (Chair: Shavara Johnson) This committee updates OKRA website content, manages and posts updates to the listserv, maintains engagement via social media, and publishes the OKRA Newsletter.

Conference Planning Committee

This work group strives to increase recycling knowledge, best practices and the economic benefits of recycling in our state, while working to reduce recycling contamination through a variety of education and communication strategies. Chaz Miller worked in recycling and waste at the US EPA, the Glass Packaging Institute and the National Waste and Recycling Association. He

is an ex officio member of the Board of the Northeast Recycling Council and a member of the Maryland Recycling Coalition Board. Chaz chaired the Montgomery County, MD, Aiming for Zero Waste Task Force. He is a recipient of the National Recycling Coalition's Lifetime Achievement Award.

Happily "semi-retired", he writes a blog for Waste360, prepares a monthly analysis of curbside recycling markets as chair of the NERC Recycling Markets Committee, and speaks at conferences about markets and recycling. He chairs the Maryland Recycling Network Legislative Committee, testifying nine times in Annapolis during the most recent legislative session.
