- D. Product Stewardship Cat Ekerd 11:34 OMDSC has three "sharps stipends" left. Amanda Schofield and Cat Ecker visited a new E-Waste facility in Tulsa, the "Sustain Group". There is also supposed to be a new facility opening in OKC. Cat will send a meeting date to Ellen Bussert. Eric Pollard mentioned that recent grant applications have now started to include a component associated with construction waste.
- E. Glass Work Group Fenton Rood 11:37 AM The work group has not been active but Fenton was hoping that board members could share how things have been going with glass recycling processors. Megan Waters said that her organization is still using Dlubak and they opted to pay the cost of having the bins. Bret Scovill in Norman have been shipping 44,000 lbs. to Kansas City every other month. Paul said that MWC is still using Dlubak and there are not any issues after the change was made to comingle the glass waste stream. Sara Ivey said that Fertile Ground has had no change in their glass recycling.

 - 1. DEQ Composting Rules Advisory Council met on 1/11/24. Any composter taking between 50 and 100 tons of type 1 & 2 feed stock will get a lighter version of a permit but anyone receiving more than 100 tons will need to get a full blown permit for the operation. According to Amanda Schofield, there were more folks at this public meeting than she's ever seen.
